Thank you for your correspondence to our office regarding the executive clemency process.

The power to grant executive clemency is established by the Constitution of Arkansas. Executive clemency is an act of mercy given at the sole discretion of the Governor. There are no standards upon which he must rely to decide who may or may not receive clemency. The Governor bases his decision on each file as submitted to him without any preconceived notions or biases. He gives each individual file careful consideration, as it is his duty to do under the Constitution.

You will be eligible to reapply for executive clemency after June 10, 2006.
